2) Minutes of the council meeting held on the 19th September 2024 copies of which had been Circulated, the minutes were confirmed and signed by the Chairman

4) MATTERS ARISING

- a National Highways Flooding and closing the road at Marley Lane Junction They advised the flooding is caused by the road being low at the junction and also being on a flood plain. It would be too costly to raise the road for the amount of time there is flooding needing the toad to be closed. The also advised they will look at and possibly consider in future closing the A.21 at Johns Cross and diverting traffic down the A.2100.
- **b** Meeting with our M.P. Kieran Mullen Councillors decided to suggest January or March which is the Parish Assembly and could be helpful
- c East Sussex Highways Lowering the speed limits in the parish They advised they will be assessing the C.293, B2090 and B.2089 to see if these roads need to have a lower sped limit and also if pathways can be sited.
 - The Chairman asked if the clerk could write to them asking for the white center lines to be reinstated as following work on the road these were covered up. Drivers are finding cars being driven in the center of the road, very dangerous around bends. Councillors were divided on this, as the road is a country road and should not have lines, but as they were there and it is for safety They agreed on asking for these to be reinstated.
- **d** A parishioner had also written to East Sussex Highways regarding the danger from speeding vehicles to pedestrians and asking for a lower speed limit.

5) CORRESPONDENCE

- a) National Highways A.21 Safety Team -The have set out the work they can implement with pathways and road crossings and also work they cannot undertake because of restrictive grass verge problems.
- b) Bus shelter being used as a toilet The Chairman said they have had five of these incidents over the past 25 years with member of the parish stepping in and clearing the mess. Councillors discussed how this could be solved but no resolution on this was voiced. It was agreed to state the problem in the Newsletter.

6) REPORT ON SPEED WATCH – STEVE TURNER

The group are now equipped with s new detector gun which has a narrower beam so better to detect speeds of oncoming traffic. The full the report was available for councillors and on our website.
