1. Introduction

Good evening, my name is Bev Marks – I am the Ramblers Local Footpath Warden for both Whatlington and Battle Civil Parishes.

Lately, I have just stepped down from being a member of the Local Access Forum - a statutory body that works with the County Council's Rights of Way team to represent the communities needs for footpath, bridleway access throughout the land. Arising from that, there is a requirement on all Local Highways Authorities - in our case East Sussex County Council – to produce a **Rights of Way Access Plan** as originated in Section 60 of Countryside and Rights of Way Act 2000, therein previously called a **Rights of Way Improvement Plan**. The current ESCC Improvement Plan is well out of date (2017), so it is good news that ESCC has now launched a public consultation questionnaire on the subject.

The timing of the consultation was decided quite urgently to avoid any 'purdah' restrictions that the national government's announcements about mayors and unitary authorities might impose.

As a former member of the LAF, I had some considerable time ago delivered Sussex Area Ramblers comments, that had been gathered over recent years, to the RoW team and consultants prior to the recent consultation, which included details from my 2x parishes. Furthermore, for completeness I responded to the consultation in February as the LFW with both Parishes needs foremost in my mind.
